



# 3rd Conference of the German Network of Forced Migration Researchers: Contexts of Displacement, Refugee Protection and Forced Migrants' Lives

17<sup>th</sup> to 19<sup>th</sup> September 2020 University of Cologne

Extended Call for Submissions: February 10th 2020

In the recent years, the interdisciplinary research landscape on forced migration, refugees and asylum has greatly expanded and differentiated in Germany. **The 3rd Conference of the Network of Forced Migration Researchers** on September 17<sup>th</sup> to 19<sup>th</sup> 2020 at the University of Cologne opens a forum for the presentation and discussion of current research as well as for the promotion of interdisciplinary exchange and cooperation. The conference presents a platform for discussion and networking of researchers in the field of refugee and forced migration studies.

The conference is organized by the *Chair for Youth Welfare and Social Work* at the University of Cologne (Prof. Dr. Nadia Kutscher) together with the steering committee of the *German Network of Forced Migration Researchers* and an interdisciplinary conference team.

We are delighted to welcome as keynote speakers **Prof. Dr. Elena Fiddian-Qasmiyeh**, University College London, UK and **Prof. Dr. Naika Foroutan**, HU Berlin, Germany.

The *Call for Submissions* addresses scientists of all disciplines involved in the field of forced migration and refugee studies as well as artists working on forced migration issues. In particular, the members of the *German Network of Forced Migration Researchers*, but also other researchers, are invited to **submit proposals until February 10**<sup>th</sup>, **2020** for the following topics:

- Forced Migration and Refugee Studies: Approaches, Methods and Research Ethics
- Agency of refugees
- Civil society, protest, resistance
- Humanitarianism: current developments regarding resilience, innovation, vulnerability etc.
- Stakeholders in forced migration
- Gender and intersectionality (race/ethnicity, religion, gender, class etc.)

- Legitimacy and Legality: Policies and practices in asylum and refugee protection
- Refugee and border regimes: actors, norms, power and impact
- Global, regional, national and local policies
- Pull and push factors of migration
- Social and Cultural participation
- "Integration" into education, work, health, housing and other areas
- Representations of forced migration and refugees in the media and the public
- Arts and Ethics: Artistic and Multimedia Work on and with refugees

### **Submissions:**

All submissions can be provided in the conference languages German or English.

#### **Format**

### **Paper**

Each presentation is scheduled for 15-20 minutes, followed by a 10 to 15 minute discussion. Submissions should be clearly relating to the above topics.

In addition to single papers, panel proposals can also be submitted. Panels should relate to specific topics and include a maximum of three presentations. Interdisciplinary panels are very welcome. Time frame for panel sessions: 90 minutes.

## Roundtable

Roundtables open up discussion forums with 4-6 people on a panel, an extended audience participation and a total length of 90 min. Each panel participant is invited to an introductory statement with 5-6 minutes' length each, which is followed by a joint discussion of the presentations with participation of the audience for 60 minutes.
